Floors are cleaned and vacuumed on a daily basis, and all lighting is kept in working order. Any defects are dealt with at the first opportunity. It is recommended that pupils avoid visiting the café/gift shop area especially when the station is busy. | 1 | 1 | 1 |

Fire alarm call points are located beside all doors. Fire extinguishers are located within the building and are all maintained on a regular basis by contractors. The whole perimeter of the decked area, save two entrance/exit points, is fenced. The exit towards the tram tracks has been 'dog-legged' to stop children running out in front of a tram. Access to the depot is prevented by means of a tram. During school visits, pupils to remain with allocated adult supervisor at all times. Tram drivers are instructed to observe additional caution in this area should anyone access the track without authorisation. The halt is fully fenced along its full length. Brick paving and slabs on the approach are inspected on a regular basis and any 'rising slabs' are dealt with immediately to prevent and trip hazard. | Waiting to board tram for return journey | Pupils and supervising staff Risk of straying onto track and collision with moving tram | Trams load passengers at the south end of platform. School staff and pupils will queue on the south end of the platform as directed by Tramway staff. There is a barrier to prevent passengers moving off the platform onto the track. Tramway staff will direct pupils and staff to the waiting area and will accompany them on the return journey. | 1 | 3 | 3 |
| Walking to or from car park including overflow car park | Pupils and supervising staff Risk of collision with moving vehicles | School staff to accompany pupils across the road or car park. School staff to remind children to be extra vigilant by looking out for moving vehicles and not to run.
